

Catch a Train, Catch a Game Sweepstakes
Official Rules
No Purchase Necessary
Open Only to Legal U.S. Residents

The Catch a Train, Catch a Game Sweepstakes (“Sweepstakes”) begins on May 8, 2010 and ends on June 8, 2010 (the “Sweepstakes Entry Period”). The Sweepstakes is sponsored by the Missouri Highways and Transportation Commission, the Missouri Department of Transportation, the Missouri Division of Tourism and Amtrak Missouri River Runner (“Sponsors”).

Eligibility: Sweepstakes is open only to legal residents of the United States, who, as of the time of entry, are eighteen (18) years or older. Online entrants must have e-mail access as of May 8, 2010. Employees and their immediate families, including household members, of the Sponsors or their parent, affiliates, subsidiaries, divisions and advertising and promotion agencies are not eligible to enter.

How to Enter: NO PURCHASE NECESSARY. Sweepstakes void where prohibited. Only one entry per person allowed. Enter online at www.morail.org and submit an entry during the Sweepstakes Entry Period, or hand print your name; address (including zip code); age; e-mail address; phone number, with area code; and your choice of attending the Royals or Cardinals baseball game on entry form and send to: MoDOT, Catch a Train, Catch a Game Sweepstakes, PO Box 270, Jefferson City, MO 65102. Entry forms will be available online or at one of the ten Amtrak stations on the St. Louis to Kansas City rail corridor. **All entries must be received by June 8, 2010 at 5:00 PM C.T. Entries received past the 5:00 p.m., June 8, 2010 deadline will not be accepted.**

Conditions of Entry: Incomplete entries will not be accepted. Entry must reflect choice of either the Cardinals or Royals package, but not both. If no selection is made, or if both are selected, then the entry will be considered incomplete. All entries in the Sweepstakes become the sole property of the Sponsors and no legal rights of any kind to such entries shall be retained by the submitting entrants. By participating, entrants agree to these Official Rules, including all eligibility requirements. Neither the Sponsors nor any telephone network or service providers are responsible for incorrect or inaccurate transcription of entry information, or for any human error, technical malfunctions, lost/delayed data transmissions, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, inability to access any website or online service, or any other error or malfunction, or late, lost, misdirected, illegible or postage due entries.

Prizes: Two (2) grand prizes will be awarded. **Cardinals Grand Prize:** Round trip travel for four (4) people on Amtrak Missouri River Runner (approximate retail value up to \$496), four (4) tickets to the regular season Cardinals baseball game on July 17, 2010 (Cardinals vs. LA Dodgers), a one night stay for two at the Millennium Hotel St. Louis and four passes for the Gateway Arch tram will be awarded. Cardinals Grand Prize is approximately \$956 in value. **Royals Grand Prize:** Round trip travel for four (4) people on Amtrak Missouri River Runner (approximate retail value up to \$496), four (4) tickets to the regular season Royals baseball game on June 26, 2010 (Royals vs. Cardinals), a one night stay for two at the Kansas City Marriott Downtown and four passes to Science City at Union Station will be awarded. Royals Grand Prize is approximately \$956 in value. The winner’s Amtrak certificates will carry instructions for redemption. Amtrak certificates will be valid on the Amtrak Missouri River Runner service for

up to six months from receipt; however, there will be blackout dates near holidays and other times during the year. Travel on Amtrak is subject to Amtrak's Conditions of Carriage/Terms of Transportation. Certificates and tickets will be mailed or otherwise delivered to the winners.

By accepting this prize, you consent to the Sponsors use of your name and image for promotional purposes, including online announcements, without additional compensation, except where prohibited by law. All federal, state and local taxes are the sole responsibility of the winner. No prize substitution, cash substitution, or assignment or transfer of prizes is permitted, except by Amtrak for reason of unavailability in which a prize of equal or greater value will be awarded. Odds of winning depend upon the number of entries received. All prizes will be awarded. The grand prize winners will be listed on MoDOT's Web site at www.morail.org on or after June 16, 2010.

Drawing: Winners will be selected from among all eligible entries received. Grand prize winners will be determined by two (2) random drawings conducted on or about June 16, 2010.

Prize Notification: The winner will be notified by telephone and/or e-mail, if provided. The winner and companions are required to sign an affidavit of eligibility/publicity and liability release, and return it properly executed within twenty-one (21) days of attempted notification as a condition of awarding the prize. If prize notification is returned as undeliverable or the winner fails to return the affidavits and release as specified, the winner will be disqualified and an alternative winner will be selected. The Sponsors are not responsible for technical, telephone, hardware or software malfunction, lost, interrupted, incomplete, garbled or delayed electronic communications, including the inaccurate or incorrect capture of online entry information, or any other errors of any kind, however caused, that may occur in the processing of the entries in this Sweepstakes. Persons entering via the web (Internet) must provide a valid e-mail address. It is the sole responsibility of the entrant to notify the Sweepstakes judges in writing if the entrant changes his/her e-mail address after entering the Sweepstakes.
