



**Name the Train Contest
Official Rules
No Purchase Necessary**

Open Only to Legal U.S. Residents, Must be a Missouri Resident to Win

How to Enter: No purchase necessary. The Train Name Suggestion portion of this contest begins on November 10, 2008 at 8:00 a.m. Central Time (C.T.) and ends on December 10, 2008 at 4:00 p.m. C.T (the "Entry Period"). You can enter this Name the Train Contest by one of the following three means: **Online entry:** Enter by visiting MoDOT's Web site at www.morail.org and complete a Train Name Suggestion entry form. **Mail in entry:** Hand print a Train Name Suggestion, your name, address, home telephone number and e-mail address on a 3"X 5" card and mail it to: MoDOT, Name the Train Contest, PO Box 270, Jefferson City, MO 65102. **Hand-delivered entry:** Hand print a Train Name Suggestion, your name, address, home telephone number and e-mail address on a 3"X 5" card and hand-deliver it to any MoDOT district or central office (locations are listed at www.modot.org). Entry forms will be available at MoDOT district office locations. Only one entry per form or hand-written card will be allowed. All entries **must be received by December 10, 2008 at 4:00 PM C.T. Multiple entries per person are allowed for name suggestions.**

A panel of judges will select five finalists from all Train Name Suggestions submitted.

The Final Voting portion of this contest begins on December 16, 2008 at 8:00 a.m. C.T. and ends on January 16, 2009 at 5:00 p.m. C.T. You can vote for a train name by one of the following three means: **Online vote:** Vote at www.morail.org during the voting period. **Mail in vote:** Hand print the finalist name of your choice (one name only), your name, address, home telephone number and e-mail address on a 3"X 5" card and mail it to: MoDOT, Name the Train Contest, PO Box 270, Jefferson City, MO 65102. **Hand-delivered vote:** Hand print the finalist name of your choice (one name only), your name, address, home telephone number and e-mail address on a 3"X 5" card and hand-deliver it to any MoDOT district or central office (locations are listed at www.modot.org). All entries **must be received by January 16, 2009 at 5:00 p.m. C.T. Only one vote per person is allowed.**

Eligibility: This contest is open only to legal residents of the United States. You must be a legal Missouri resident to win a prize. Online entrants must have e-mail access as of December 10, 2008. Employees and their immediate families, including household members, of the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak, its parent, affiliates, subsidiaries and divisions are eligible to enter name suggestions, but are not eligible to win prizes.

Conditions of Entry: If you are entering online, you must be the registered subscriber of the e-mail account by which the entry is made prior to December 10, 2008. Incomplete entries will not be accepted. All entries in the Train Name Suggestion

portion of the contest become the sole property of the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak and no legal rights of any kind to such entries shall be retained by the submitting entrants. By participating, entrants agree to these Official Rules, including all eligibility requirements. Neither the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak, nor any telephone network or service providers are responsible for incorrect or inaccurate transcription of entry information, or for any human error, technical malfunctions, lost/delayed data transmissions, omission, interruption, deletion, defect, line failures of any telephone network, computer equipment, software, inability to access any website or online service, or any other error or malfunction, or late, lost, misdirected, illegible or postage due entries.

Prizes: Finalist Prizes: The five (5) finalists will receive two (2) round-trip tickets to any Amtrak destination in Missouri (approximate retail value up to \$304 per prize) and a gift basket donated from one (1) of five (5) participating cities that are located along the St. Louis to Kansas City passenger rail line (each basket is valued at a minimum of \$50).

Grand Prize: Round trip travel for two (2) people on Amtrak with sleeping car, if available, to any Amtrak destination in the U.S. (approximate retail value up to \$3,500) will be awarded.

The winner's certificate will carry instructions for redemption. There will be blackout dates near holidays and other times during the year. Certificates and baskets will be mailed or otherwise delivered to the winners. The train ticket prizes are non-transferable. If a finalist or grand-prize winner is under the age of 18, a legal guardian must accompany them on the train.

Odds of winning depend upon the number of entries received. After finalists are selected, the odds of winning the grand prize are 1 in 5. By accepting this prize, you consent to the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and/or Amtrak's use of your name and image for promotional purposes, including online announcements, without additional compensation, except where prohibited by law. All federal, state and local taxes are the sole responsibility of the winner. No prize substitution, cash substitution, or assignment or transfer of prizes is permitted, except by Amtrak for reason of unavailability in which a prize of equal or greater value will be awarded. All prizes will be awarded.

Judging/Drawing: A panel of seven (7) judges will select five (5) finalists from all names submitted to the Train Name Suggestion portion of the contest. The judging panel will be comprised of officials from MoDOT (3), Amtrak (2), Missouri Division of Tourism (1) and the Missouri Rail Passenger Advisory Committee (1). The finalists will be determined on or about December 15, 2008. If more than one contestant submits a name selected by the judges as one of the five (5) finalists, all contestants who submitted that name will be entered in a random drawing conducted by the judges. One contestant will be drawn as the representative of the finalist name entry. That

contestant will receive a finalist prize and be eligible to receive the grand prize, if selected. The finalist selections and any random drawing(s) shall be conducted by the panel of judges whose decisions are final with respect to all aspects of the contest.

Prize Notification: The winner will be notified by telephone, mail and/or e-mail, if provided. The winner, or their parent or legal guardian, and a companion are required to sign an affidavit of eligibility/publicity and liability release, and return it properly executed within twenty-one (21) days of attempted notification as a condition of awarding the prize. If prize notification is returned as undeliverable or the winner fails to return the affidavits and release as specified, the winner will be disqualified and an alternative winner will be selected. The Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak is not responsible for technical, telephone, hardware or software malfunction, lost, interrupted, incomplete, garbled or delayed electronic communications, including the inaccurate or incorrect capture of online entry information, or any other errors of any kind, however caused, that may occur in the processing of the entries in this contest. If, in the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and/or Amtrak's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with or alteration of any portion of the contest, or if any technical difficulties compromise the integrity of the contest, the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak reserves the right to terminate the contest or void any or all electronic entries. Persons entering via the web (Internet) must provide a valid e-mail address. It is the sole responsibility of the entrant to notify the contest judges in writing if the entrant changes his/her e-mail address after entering the contest. In case of dispute as to the identity of a winner who entered online, such entry will be declared made by the registered user of the e-mail account, and if a prize is won, and such registered user is a valid entrant, the prize will be awarded to such registered user. Any attempt to deliberately damage the content or operation of this contest is unlawful and subject to legal action by the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak or its agents.

This contest is subject to all federal, state, and local laws. Void where prohibited by law. The winner(s) agree(s) that the Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak, its affiliates and their agencies and employees shall not be liable for injury, loss or damage of any kind resulting from participating in this contest or from the acceptance or use of any prize awarded. The Missouri Highways and Transportation Commission, the Missouri Department of Transportation and Amtrak reserve the right to verify eligibility qualifications of any winner. U.S. and Missouri law governs this contest.
